Item 3 Disciplinary Information

Criminal or Civil Action: None to report.

Administrative Proceeding: In November of 2018, without admitting or denying the allegations, Mr. Stryzewski entered into a Consent Order with The State of Washington Department of Financial Institutions Securities Division. The Consent Order requires Mr. Stryzewski to cease and desist from violating RCW 21.20.0110, the anti-fraud section of the Securities Act of Washington and



RCW 21.20.040 requiring registration of securities salespersons and broker-dealers. Mr. Stryzewski was also ordered to pay a fine of \$10,000 and investigative costs of \$7,000 prior to entering into the order.

Self-Regulatory Proceeding: None to report.

Item 4 Other Business Activities

Mr. Stryzewski is the owner of Sound Tax Planning LLC; a tax planning firm which contracts third party CPAs and attorneys to assist in the formulation of various tax and legal documents. Approximately 10% of his time is spent in this capacity.

Mr. Stryzewski is an insurance agent with Sound Planning Group and spends approximately 40% of his time in this capacity.

These practices may present a conflict of interest because it gives an incentive to recommend products and services based on the commission or fees received. This conflict is mitigated by disclosures, procedures, and the firm's Fiduciary obligation to place the best interest of the Client first and the Clients are not required to purchase any products or services.

Clients have the option to purchase these products or services through the insurance agent or agency of their choosing, including those unaffiliated SPG Advisors, LLC and Sound Planning Group.
